Making a difference for dogs

A guide to help you complete an application for the registration of a Border Collie (ISDS)

The owner who wishes to register a Border Collie should complete this form in **BLOCK CAPITALS** in **black ink** throughout and send to the Kennel Club.

1 The owner(s) name & address

The owner is the person in whose name the dog is to be registered under. The declaration must be signed by all parties in the case of joint ownership. If the dog is registered with the International Sheep Dog Society (ISDS), the name of the person applying must match the current registered ownership printed on the ISDS registration certificate.

2 Dog Details

Specify the dog's status by ticking the option that applies and enclose the following documentation:

If you ticked box a), a photocopy of the dog's ISDS registration certificate must be enclosed

If you ticked box b), a photocopy of the sire's & dam's ISDS registration certificate must be enclosed

If you ticked box c), a photocopy of the dam's ISDS registration certificate must be enclosed

Please note, it may be necessary to request a photocopy of the official pedigree certified by the International Sheep Dog Society, should we not hold on our records sufficient details of the dog's ancestry.

Dog Naming Guidelines (Please read carefully)

- i. If the dog is registered with the ISDS, the name as it appears on its registration certificate must be incorporated as part of the name.
- ii. A name must consist of more than one word but not exceed 24 letters.
- iii. A name which conflicts with an active Kennel Name granted to another person will not be accepted, unless it is the name that the dog is registered as with the ISDS.
- iv. The surname of the breeder/current owner is not acceptable.
- v. If a Kennel Name is to be used, it must appear as the first word if named by the breeder. If you are not the breeder of the dog, or the breeder of both the parents, the Kennel Name must appear as the last word of the name.

- vi. Initials cannot be used & abbreviations may be disallowed.
- vii. Canine terms are not permissible, e.g. "dog", "bitch", "Kennel", "Champion" and specific names of breeds.

viii. A registered name cannot be used again within a breed.

The Kennel Club reserves the right to refuse any name, which it considers inappropriate or offensive.

The Kennel Club also retains the right to request a fresh name for any dog after the registration has been accepted, in the event of a complaint being lodged with the Kennel Club, which is upheld.

3 The Breeder(s) name & address

The breeder is the person who bred the dog. If the application is for a dog registered with the ISDS, the breeder's signature is not required. However, if the application is for a dog born to a bitch registered with the ISDS, the breeder's details and signature are required and must match the current ownership of the bitch on the ISDS certificate.

4 Fee

The fee to register a Border Collie is £13.00.

- i. The committee reserves the right to reject any application to register a Kennel Name or transfer any dog or to change or cancel or suspend any registration and may cancel or suspend any registration or transfer or grant of a Kennel Name already made.
- ii. The acceptance of a registration is not a guarantee of its accuracy.
- iii. When submitted, this form remains the property of the Kennel Club.
- iv. The data connected to your dog, including all health screening results submitted with your application will be published and used for registration, research (statistical purposes) and publication in relevant Kennel Club documentation and also included in the Health Test Result Finder and Mate Select calculations.
