- Use **CAPITAL LETTERS** when completing either form.
- All sections in **YELLOW and their associated fields** are mandatory and must be completed.

General instructions on how to complete the optional form (included in the back of the judge's book)

The optional form is applicable to Judges of breeds that are not currently listed on Breed Watch and should only be completed if the Judge wants to alert the Kennel Club to any emerging visible health concerns.

Also note that the form needs to be dated and signed.

B. PLEASE ANSWER THE FOLLOWING QUESTIONS	
1. What was your impression of the overall health and well-being of the dogs shown today?	
Overall I was happy with the health of dogs presented at the show. However I had a small concern about weak hindquarters in 10% of my entry.	
2. Did you notice any issues, exaggerations or faults in this breed that you would like to record?	
Weak movement caused by weak hindquarters in approximately 10% of my entry.
