	TO:	
	When entered for a competition in a standard class, a dog must be entered at the	
	level for which it is eligible. The dog may also, if desired, be entered in up to two	
	additional classes, one further standard class at the subsequent higher level, one	
	additional special class, or two additional special classes. A dog may be entered in	
	special classes only, up to a maximum of 3 classes. Special classes do not count	
	towards progression. Once a dog has gained any level or excellent title, it is no	
	longer eligible for any lower level.

Regulation S(C) 56. SIT LEAVE DOG - RECALL OVER JUMP. TO: This exercise requires two signs. At the first sign (A) the handler and dog stop with the dog sitting at heel. The jump must be approximately 4 metres from sign (A). The handler cues the dog to wait then walks to the second sign (B) which is approximately 4 metres away from the opposite side of the jump. The handler turns and faces the dog and recalls the dog. The dog must come over the jump and sit in front of the handler. The handler then cues the dog to Finish either Right or Left. (Insertion in bold) (Effective 1 January 2020)	
Regulation S(C) 66. SIT - LEAVE DOG - ANGLED RECALL OVER JUMP. TO: This exercise requires two signs. At the first sign (A) the handler and dog stop with the dog sitting at heel. The jump must be approximately 4 metres from sign (A). The handler cues the dog to wait then walks to the second sign (B) which is placed approximately 4 metres away from the jump and 1 metre to either the right or left of the jump. The handler turns and faces the dog and cues the dog to jump. The dog must come over the jump and sit straight in front of the handler. The handler then cues the dog to Finish either Right or Left. Regulation S(B)3.i.Bonus Exercise TO: The Bonus Exercise is an optional exercise. Handlers are not required to perform the Bonus Exercise, but must advise the judge at the Start Line if they wish to do so (Deletion struck through) (Effective 1 January 2020) Regulation S(B)2 TO: (2) Once used, an exercise should not be repeated, with the exception of right and left turns and normal pace .

Regulation S(C) Sign17 TO: NORMAL PACE. As the dog/handler team draw level with the sign they move at a normal pace that is comfortable for the dog and handler. Regulation S(C)59 TO: 59. SEND OVER JUMP - HANDLER RUNS BY. As the handler and dog team approach the sign the handler sends the dog towards the jump which is appro 4 metres in front of and 1.5 metres to the left of their path. The handler continu- brisk pace along a line 1.5 metres to the right of the jump. When the dog has completed the jump, the handler calls the dog to the heel position and the dog team continues to the return to their normal pace as they heel towards the exercise approximately 4 metres ahead. If the dog is much faster than the har the dog may be called back to the handler without penalty. A line may be draw the ground to indicate the 1.5 metres mark. NB. This sign is now placed on the handler's right, not on their left where it was previously placed. (Deletion struck through. 5.	Inter-Regional Competition at Crufts	It was noted that Mrs Garner had decided to stand down from her role as Event Co- ordinator for the Rally and Obedience Inter-Regional competition at Crufts, and Mrs Bradley, had been appointed to take over the Rally role from 2020 onwards. 6.	Videos of exercises	A suggestion of providing videos to assist competitors understanding of how exercises should be performed was discussed. The Working Party agreed that short films relating to the way in which any individual exercises should be judged and marked would be very useful for both judges and competitors. The matter is to be considered and progressed via the Activities Judges SubGroup.	Competitors and judges to note.
7.	Judging and competing at the same competition	It was noted that the matter had already been given adequate consideration on previous occasions, and the Working Party was not of the view that any change to the relevant Regulation should be made.	Judges and competition organisers to note.

8.	Integrity of exercises	The Working Party considered the Integrity of exercises, and concluded that all exercises should stand-alone and should not impinge on any other exercise. It made recommendations for a relevant amendment to S Regulations, which would be subject to consideration by the Activities Committee and subsequently by the Board. The Working Party agreed that simple and clear guidance should be provided to Chief	Competitors, judges, competition organisers and chief stewards to note.
		Stewards, and should also be incorporated into the revised Guide for Rally Judges.	
9.	Clarification of Regulations	The Working Party discussed a request to clarify whether a competitor must advise the judge at the start of the course if they intended to perform the Bonus Exercise or not.	Competitors, judges and competition organisers to note
		The Working Party was of the view that a competitor may perform the Bonus Exercise if they wished to do so, but did not consider it necessary that the judge should be advised at the start of the course. However, they must ensure that they had any necessary equipment with them. Regulation change listed in subject 2 (Regulation Amendments).	
		The Working Party discussed how an additional cue, and an extended cue, may be defined for the purpose of scoring. It was of the view that it was not possible to be too prescriptive in respect of how additional and extended cues should be defined, and that judges should be permitted to use their own discretion. It was noted that the proposed training videos would provide guidance for judges on this issue.	
10.	Rally Events at Breed Shows	A Successful KC Rally competition took place on Monday 6th August 2018 at Paignton and District Fanciers' Association. It was hoped Rally competitions would run again from 2020 onwards.	Competitors, judges and competition organisers to note.
		A Have A Go Rally session was held at United Kingdom Toy Dog Society on the 30th March 2019 and it was understood that it was a very positive experience for those taking part.	
		The Working Party noted, at its 23 July meeting, that a good number of toy breed dogs took part in Rally and it was hoped that the Society would continue to support Rally.	



11.	Communication with the Rally Community	The Working Party wished to encourage members of the Rally community to email members of the Working Party with any suggestions or concerns, or talk to them at competitions.	Competitors, judges and competition organisers to note.

12.	ҮКС	It was noted that only 5 competitors had taken part in the YKC Rally competition at Crufts 2019, although the standard had been very high. The YKC would in future be offering Rally training in the hope that the number of young handlers would increase.	YKC members to note.
13.	Clarification on blind dogs participating in Kennel Club licensed competitions	The Working Party wished to reiterate the views of the Activities Committee on this matter, following a query raised by Rally competitors. The Activities Committee is of the view that blind dogs must not compete in Kennel Club licensed competitions. The Committee was strongly of the view that all dog owners must be mindful of a dog's welfare when putting it into a competitive situation.	Competitors, judges and show organisers to note.
14.	Clarification on collars	The Working Party wished to emphasise that a half-slip, or half-check type of collar was not permitted within the S Regulations. It was clarified that decorations such as printed patterns, or crystals embedded into a collar did not contravene the Regulation and should not be used as a reason to NQ a dog. 15.	Proposal to allow food and toy rewards in Special classes	The Working Party made a recommendation that food and toy rewards should be permissible in Special classes when detailed in the schedule. The recommendation would be subject to consideration by the Activities Committee and subsequently by the Board.	Competitors, judges and show organisers to note.
