11.	Inter-regional Rally competition at Crufts	Revised rules, applicable to the Inter-Regional Rally competition at Crufts in 2019, have been approved by the Crufts Committee whereby teams will in future only include one Level 2 dog, making a team of six with a Level 1 reserve.	Competitors to note.
12.	Rally events at breed shows	A number of breed shows are offering Rally events and all competitors are encouraged to support them.	Competitors to note.
13.	Young Kennel Club (YKC)	A team of YKC handlers had been featured doing Rally at the Caravan Show in February, and it was hoped this would continue in future. Following feedback from Junior handlers, it had been decided not to hold specific YKC Rally classes at some shows this year. Junior handlers are instead being encouraged to enter standard classes alongside adults but numbers of young handlers remained low and more promotion was needed.	YKC members to note.

Course plans	The Working Party noted concerns regarding recent instances of judges designing courses which were not acceptable. It noted that in future, judges would be required to submit course plans to Chief Stewards prior to a competition taking place. It was hoped that any issues concerning course plans could be dealt with by means of tact and diplomacy by both judges and Chief Stewards. However, in cases where an official considered himself or herself to have been the subject of intimidation or inappropriate behaviour, a report should be made in the competition's Incident Book.
