#### Regulation I30.i.

One close fitting smooth collar must be worn. The only attachment permitted is a form of identification. Dogs must not wear any type of slip or half-slip collar when under test.

(Insertion in bold)

Effective date: 1 January 2019

**Note**: The Activities Committee, at its meeting on 14 June 2018, raised a concern that the wording proposed by the Council stated that only a leather or webbing collar would be permissible, as it considered this to be unduly restrictive. It was agreed that instead the word 'smooth' should be used. Further, the Board, on considering the wording of the Regulation, stated that a collar must be worn and accordingly, it approved the revised wording as above.

#### Regulation I(C)2

#### TO:

2. Heelwork. - ... Where required the lead should be of a slip type or attached to a smooth close fitting smooth collar or slip chain. Retractable leads or head collars are not to be used.

#### b. Progression and eligibility issues

The Activities Committee, in considering proposals submitted by the Council, wished to suggest that issues of progression and eligibility should be considered as a whole by the Council with a view to producing a package of measures designed to attract new competitors and to retain existing ones in order to address the decreasing number of entries. It was acknowledged that this would involve a consultation process in which the views of competitors would be assessed and taken into account.

- (i) Accordingly, the Council is requested to consider the formation of a Working Party from within the Council, to be tasked specifically with giving detailed consideration to progression issues, with the objective of encouraging wider participation in the discipline.
- (ii) In addition, the Committee suggested that the encouragement of young handlers was another issue which may be considered by the proposed Working Party as part of its remit.

#### c. <u>Dogs biting on the right arm</u>

At its previous meeting, the Council considered whether there should be any regulation to state that dogs must bite on the right arm. It was agreed that a suitable proposal may be considered by the Council at its next meeting. It is invited to note that two proposals have been submitted and are included on the agenda under items 13b. and 13.c.

#### d. Research project

At its previous meeting, the Council noted that, following its request for research based on comparisons of dogs traversing a 5 foot scale versus a 6 foot scale; and an 8 foot long jump versus a 9 foot long jump, a formal proposal was being formulated. An update is provided under item 10.

e. Proposed review of Regulations for Bloodhound Trials relating to entries/qualifications



At its previous meeting, the Council discussed a proposed review of I(D) Regulations relating to Bloodhound Trials in order to address the issue of higher stakes becoming 'top heavy' as a result of reduced entries at trials. In particular it considered the potential reinstatement of the nomination system, in order to encourage numbers competing at lower levels. It was agreed that discussions between the two societies concerned would take place, with a view to a formal proposal being submitted to the Council.

The Council is invited to note responses from the Bloodhound Club and the Association of Bloodhound Breeders.

### **ITEM 9. INSURANCE ISSUES**

A representative from Howden, the insurance broker acting on behalf of Hiscox Insurance (the Kennel Club's insurance provider) has been invited to attend the meeting via a teleconference call in order to address issues raised by Council members.

#### ITEM 10. ACTIVITIES JUDGES SUB-GROUP

The Council is invited to note an update on the Sub-Group's progress since the Council's last meeting.

Mr Gilbert wishes to report that filming for the Working Trials presentation, which would be made available on the Kennel Club Academy website, took place in September 2018. Work is currently in progress to finalise the film.

It is hoped that a further update will be available at the meeting.

c. Criteria for judges for the Kennel Club Working Trials Championships
The Council is invited to note that subsequent to its 2018 meeting, the Activities
Committee noted that the existing criteria for judges for the Kennel Club Working Trial
Championships included the requirement for a judge to have attended the relevant
Working Trial judges' seminar, but did not explicitly state that he/she must have passed
the examination. It agreed that this requirement should be added to the criteria, for the
purposes of clarity and completeness.

#### **ITEM 13. FIVE YEAR STRATEGY**

The Council is invited to consider the Five Year Strategy document and to discuss how it may be implemented, noting that at its 2018 meeting, a concern had been raised that the strategy for the discipline had not been developed or progressed for some time. #### ITEM 14. PROPOSALS FROM SOCIETIES/PRIVATE INDIVIDUALS

a. <u>Surrey Dog Training Society</u>
 Proposed amendment to Regulation I27.(c)

Mr M Lewindon

The Society wishes to propose an amendment to the above Regulation.

Regulation I27.(c). Judging.

TO:

c. The Judge or Judges in consultation with the Working Trial Manager may arrange for dogs to be working singly or together in any numbers. All dogs entered in a Stake shall be tested as far as possible under similar conditions. Immediately before undertaking an exercise, competitors will be told, by the judge or steward on the judge's behalf, which exercise they are being required to attempt.

#### Rationale

Working Trials tests are rich because of the variety and flexibility in how exercises are set and the order in which they are arranged. Competitors should, however, understand what they are expected to do to achieve the requisite number of points to qualify and potentially win competitions. Additionally, within Patrol Dog stakes, clarity in what is expected is critical to ensure the safety of those taking part.

Note: proposals b. and c. below cover the same issue and should be considered together.



## b. North West Working Trials Society Proposal for an amendment to Regulation I(C)17

Mrs J Holt

The Society wishes to propose the following amendment:

Regulation I(C)17

TO:

17. Pursuit and Detention of Protected Stewards.—The 'protected steward' (a different one for choice) and handler should be introduced as above, and the dog sent forward under similar conditions. The 'protected steward' must continue to attempt to escape and, if possible, should do so through an exit or into a vehicle once the dog has had a chance to catch up with him. The dog must be regarded as having succeeded if it clearly prevents the 'protected steward' from continuing to flee by holding him by the protected right arm. If the dog fails to make a convincing attempt to detain the 'protected steward', it shall lose any marks that it may have obtained for the Recall from Protected Stewards exercise or alternatively, it shall not be tested on the Recall that follows the Pursuit and Detention of Protected Stewards exercise.

#### Rationale

It has always been custom and practice that the protected arm was the right arm, although this has never been specified in the Description of Exercises and Guidance for Judges, Regulations I(C). It is considered that this clarity is necessary for the benefit of both PD competitors and judges.

#### C. Mr J Wykes

Proposal for an amendment to Regulation I(C)17

Mr Wykes, an individual, wishes the Council to consider the following amendment to Regulation I(C)17:

#### Regulation I(C)17

TO:

17. Pursuit and Detention of Protected Stewards.—The 'protected steward' (a different one for choice) and handler should be introduced as above, and the dog sent forward under similar conditions. The 'protected steward' must continue to attempt to escape and, if possible, should do so through an exit or into a vehicle once the dog has had a chance to catch up with him. The dog must be regarded as having succeeded if it clearly prevents the 'protected steward' from continuing to flee by holding him by the protected arm. If the dog fails to make a convincing attempt to detain the 'protected steward', it shall lose any marks that it may have obtained for the Recall from Protected Stewards exercise or alternatively, it shall not be tested on the Recall that follows the Pursuit and Detention of Protected Stewards exercise. In any exercise where the dog is required to bite a protected steward (protected consistent with safety), it must be on the right arm between elbow and wrist. Any indiscriminate biting must be severely penalised.

#### Rationale

The objective of the proposed amendment is to ensure that dogs are only trained to bite on the right arm in the interests of safety.

#### d. Ms F Mckenzie

Mr D Robertson

Proposal for amendment to Regulation I(D).6.h

Ms Mckenzie wishes to Council to consider the following addition to Regulation I(D)6.:



Regulation I(D)6.h

TO:

Should cattle be present, the Stake Manager must inform line walkers that a diversion should be made to avoid walking through them. If a reasonable diversion is not possible then the line should be aborted and a spare line used. (Insertion in bold.)

#### Rationale

The proposal is made following a serious incident which occurred at a recent Bloodhound trial in which a Bloodhound was injured by cattle. Ms Mckenzie wishes to stress that there are many reported incidents every year in which walkers, with and without dogs, are badly injured or killed by cattle, and is of the view that any potential danger to competitors and/or hounds should be avoided if possible.

## a. Yorkshire Working Trials Society

#### Number of meetings

The Society would like to suggest that two Liaison Council meetings are scheduled each year. It is of the view that if a second meeting, probably in October was scheduled, then societies would submit items. If there are insufficient items to justify a second meeting, then it would not be confirmed. It would also offer the advantage of allowing the Council to discuss matters referred back to it from the Activities Committee if necessary.

#### b. <u>Yorkshire Working Trials Society</u>

#### Removal of the gun test

The Society requests that the Council discuss the removal of the gun test from Working Trials tests, and the marks in that section redistributed. It notes that many triallists are of the view that this exercise is no longer necessary.

If the Council is in agreement with removal of the gun test, further discussion would be required as to how the marks should be redistributed.

### c. Ms F Atkin

Miss J Carruthers

#### Qualification for Championship CD Stake

Ms Atkin, an individual, requests that the Council consider a review of making CD Open a compulsory requirement to progress to CD Championship.

The current Regulation I(A)6.b. is as follows:

Companion Dog (C.D.) Stake—For dogs which have not qualified W.D. Ex.

#### Rationale

It is anticipated that doing so would elevate the perceived value of the CD Open Stake. Further, it would bring CD into line with all the other open stakes as a requirement for progression into championship stakes, and if approved would result in an increase in the number of dogs competing in CD Open Stakes.

## d. Southern Alsatian Training Society

### Refusal of entries

The Society requests that the Council discuss the procedure to be followed should a club wish to refuse entries from a particular individual, or for a particular dog. It wishes to ensure that the procedure is fair, reasoned and transparent, and suggests that clubs



should advise the individual concerned of the reason behind any decision to refuse entries in order to allow him or her the opportunity to amend their conduct or to offer an apology, if appropriate.

Further, the Council is requested to consider ways in which guidance on the correct procedures may be disseminated to clubs.

A copy of the Kennel Club's 'General advice on the exercise of the right of Societies to refuse entries to Kennel Club Licensed Events' document guidance is attached for reference.

#### e. Mr J Wykes

Introductory Stake

Mr Wykes requests the Council to discuss the merits of the Introductory Stake, and to consider ways in which it may be improved.

#### f. <u>Progression issues</u>

Mr Wykes

Mr Wykes wishes the Council to discuss progression through the stakes and ways in which it could be improved.

#### ITEM 16. MARKING UP OF CATALOGUES

The Council is invited by the office to agree a standard method for marking up Working Trial catalogues to indicate qualification marks. This is requested in order to ensure clarity as to which dogs have qualified in the Tracking or Patrol Dog stake and which dogs have gained Excellent qualifications in these Stakes.

At present there are inconsistencies in the way catalogues are marked up by different societies, resulting in time-consuming errors and queries when compiling Stud Book proofs, and the possibility of Stud Book certificates being issued incorrectly.

#### **ITEM 17. ANY OTHER BUSINESS**

Please give at least two weeks advance notice of matters to be raised under 'Any Other Business' as this assists the office if research is required. These items are discussed at the discretion of the Chairman.

## **ITEM 18. DATE OF NEXT MEETING**

The date of the next meeting will be confirmed in September 2019.
