# Get to know the Field Trials Committee

# **Steven Chant**

#### 1. How did you start to be involved in field trials?

I was put in touch with Liz and Edward Hardman with the Bredebeck Weimaraners who were living in Dorset at the time my wife and I were researching the breed. When I eventually bought my first Weimaraner I joined them for gundog training and we became friends. As I enjoyed working my dogs and shooting over them it was suggested that if I was interested, I could attend some trials to watch and learn. I really enjoyed attending these trials and meeting those folks who were running dogs. Happy to lend a hand, Edward invited me to carry the Red Flag, then to Steward and to shoot. It wasn't until I had my second Weimaraner that I became involved in trialing. I really enjoyed the trialing world, my fellow competitors whose company and advice I valued and being able to watch some wonderful dogs working on some amazing grounds.

#### 2. What's your greatest success in Field Trials to date?

Breeding FT Ch Quadet Caterin owned by Dave Pilkington and SH Ch, Swedish FT Ch and Bloodtracking Ch Quadet Damit owned by Elisabeth Beskow. Another great success was making up my second Weimaraner, Tasairgid Talked About into a full CH. Winning the Swedish Weimaraner FT Championship with Q Dacke and being awarded the best hunting dog trophy on two occasions at this event.

Although not a FT, I have enjoyed and had success running dogs at Spring and Grouse Pointing Tests.

#### 3. What's the best advice you've ever been given? Never over estimate your own dog's ability.

# 4. What's the most memorable dog that you haven't owned?

The wonderful Hungarian Vizsla, FT Ch Archenfield Crusty of Waidman.

#### 5. Away from dogs, what do you like to do to relax?

I enjoy amateur dramatics and have taken part in a variety of pantos and plays since a child. These days I am a member of the New Hardy Players. I have a small part in their latest production, The Mayor of Casterbridge, which my sister is very involved with. The money raised by these productions goes to local charities.

# 6. What advice would you give someone starting in field trials?

I would urge people not to be in a rush. Be prepared to roll your sleeves up and help. Watch, listen to the positives and learn. Be realistic and honest about yourself and your dog. Take your time over your training and make sure it is fun for your dog and for you. Be a good sport and enjoy watching the other dogs working.

#### 7. Why did you get the breed of dog you have?

My work at the time and our lifestyle made my wife and I decide to go for a short coated breed for our second dog. After reading an interesting article on the Weimaraner but not having seen or met one we started to research the breed. Many people warned us against having one but over 40 years later I am still hooked! The breed has had a huge impact on our lives and I am still involved with the Weimaraner Club of Great Britain. Importing a dog from Sweden has been one of the major highlights of my life as through this I have made some wonderful friends and travelled around a beautiful country.

"I want to change my dog" is quite a common cry Make sure you check their aim and all the rules thereby They tell a good tale, with charm they do beguile Get your answer right quoting the rules with a smile

The B Judge has been found, fast asleep in his car Dreaming no doubt of that last drink in the bar! Keeper and Guns are assembled for the speeches Bedecked in colourful tweed and very posh breeches

The Host has arrived so prepare to depart Call everyone up for introductions to start The Host wishes to speak and name his special guests Make sure they all have armbands and perhaps a high viz vest

Introduce the Keeper, Guns and Pickers-Up depending where they are

# **Obituary to Malcolm Taylor**

It is with deepest regret that I find myself writing this in memory of Malcolm Taylor, who sadly passed away earlier this year after a long battle with cancer. I knew John Malcolm Taylor for well over 20 years, and all that time we were very good friends.

Malcolm was a very hard working ambassador of the Tyne Tees & Tweed Field Trial Association and one of the original few members who started the Tyne Tees & Tweed Field Trial Association, originally a Spaniel Club, but by the tenacity of Malcolm and his visits to the Kennel Club became a Retriever Club as well.

Although Malcolm had a very demanding position work wise, he had an office in England, Sweden and Paris he made time for his beloved Spaniels!

Malcolm competed at all levels and moved up the ranks to achieve A panel status and ultimately judged the Spaniel championship.

The day came when I was Retriever Secretary and Malcolm rang to suggest if I could organise a 24 dog open retriever trial he could get the guns, and that went on for years, years of laughter enjoyment and friendship, like one big happy family with Malcolm right at the forefront.

Malcolm then turned his efforts into being Liaison Council representative for the Tyne, Tees & Tweed Field Trials Association, Yorkshire Gundog Club and Vale of York Working Retriever Club, until he was voted Chairman of the Liaison Council at The Kennel Club.

Malcolm Taylor never stopped! A panel Spaniel Judge, shooting at Trials, competing in Spaniel Trials, President of the Tyne Tees & Tweed, organising Spaniel working Tests, salmon fishing when possible and latterly doing Novice gundog training for The Kennel Club at various areas from Scotland to Southern Counties with Anne Heading and the Working Party.

He is a man who will be sadly missed but never forgotten throughout the gundog world.

#### **Dougy Armstrong**

Malcolm Taylor became chairman of the Field Trial Liaison Council in May 2013, serving two three year terms in the role. He became a member of the Field Trials Committee in June 2013, and was elected Vice-Chairman in June 2017, a role he held until poor health forced his reluctant resignation from the Committee in April 2019.

The Field Trial Liaison Council is a large group, consisting of approximately 50 delegates, and there is generally a lot to discuss. Sometimes there is a wide range of divergent views resulting in lively discussion, but Malcolm was always able to use his intelligence, natural charm, and good humour to pilot Council meetings to amicable and constructive resolutions, and all in a way that ensured that those meetings - even those with lengthy and complex agendas - did not go on until midnight. His knowledge and experience of the field trialling world meant that he could clearly pick out the salient points of topics under discussion, whilst being able to understand, and empathise with, both sides of a debate. This was of enormous help in progressing Council business in a positive and constructive way. This thoughtful and balanced approach was also evident in his highly-valued contributions to the work of the Field Trials Committee.

Always a pleasure to work with, Malcolm was highly popular with Kennel Club staff. He was always happy to provide help, support, and expertise whenever needed, and his visits to Clarges St. were always welcome. Malcolm's sense of humour was well known and he was always smiling, never taking himself too seriously. Staff remained in touch with him throughout his illness, and breathed a sigh of relief every time there was positive news about his treatment. All those who had come into contact with him were hugely saddened when learning of his passing.

A man of great good humour, kindness, and knowledge, he is very much missed.

# **J Regulations**

The Board approved the following amendments to the J Regulations, which were recommended by the Field Trials Committee at its April 2021 meeting:

In the interest of clarity and to avoid duplication, the deletion of Regulation J4 was recommended and subsequently approved by the Board. This information is included in Regualtion J(B), J(C), J(D) and J(E) which related to each of the four sub-groups.

Regulation J4:

TO:

Numbers of runners

To qualify for entry in the Kennel Club Stud Book the numbersof runners permitted is as follows:

a. Retrievers

(1) Two-day Open stakes - maximum 24, minimum 20. (2) One-day Open stakes - maximum 16, minimum 10. (3) Other stakes per day - maximum 16, minimum 10. (4) Championship - no maximum number.

#### b. Spaniels

(1) Open stakes - maximum 18, minimum 14.

- (2) Other stakes maximum 18, minimum 12.
- (3) Cocker and Any Variety Spaniel [Excluding Spaniel (Cocker)] or Championships - no maximum number
- c. Pointers and Setters
- (1) Open stakes maximum 40, minimum 16 When an Open and any other type of stake are to run on the same day, the maximum number of runners over the whole day is 45
- (2) Novice/All Aged stakes maximum 45, minimum 12-
- (3) Puppy stakes maximum 45, minimum 8
- (4) Champion stake no maximum number

d. Hunt, Point and Retrieve

(1) Open stakes - maximum 12, minimum 10. (2) Other stakes - maximum 12, minimum 8.

With the exception of the Cocker and English Springer Spaniel Championships, to To qualify for entry in the Kennel Club Stud Book, the number of runners permitted in stakes is as follows:

- a. Open Stakes maximum 18, minimum 14.
- b. Other Stakes maximum 18, minimum 12.
- c. Any Variety Spaniel (Except Spaniel [Cocker] and Spaniel [English Springer]) - maximum 18, minimum 10. Spaniel (Cocker) and Spaniel (English Springer) <del>c.</del>

Championships - no maximum number.

Open Spaniel Stakes are presently confined to Spaniels (Cocker) and Spaniels (English Springer).

(Insertions in bold. Deletions struck through.) (Effective 1 July 2021)

Regulation J(B)2 Number of runners:

#### TO:

With the exception of the Retriever Championship, to **To** qualify for entry in the Kennel Club Stud Book, the number of runners permitted in Stakes is <del>as follows</del>:

(a) Two-day Open Stakes: maximum 24, minimum 20.(b) One-day Open Stakes: maximum 16, minimum 10.(c) Other Stakes per day: maximum 16, minimum 10

(Insertion in bold. Deletions struck through.) (Effective 1 July 2021)

Regulation J(D)2 Number of runners:

#### TO:

With the exception of the Pointer and Setter Champion Stake, to **To** qualify for entry in the Kennel Club Stud Book, the number of runners permitted in stakes is <del>as follows</del>:

a. Open Stakes: maximum 40, minimum 16.

- b. Novice/All Aged Stakes: maximum 45, minimum 12.
- c. Puppy Stakes: maximum 45, minimum 8. Where an open and any other type of stake are to run on the same day, the maximum number of runners over the whole day is 45.

(Insertion in bold. Deletions struck through.) (Effective 1 July 2021)

Regulation J(E)2 Number of runners:

#### TO:

With the exception of the Hunt, Point and Retrieve-Championship, to **To** qualify for entry in the Kennel Club Stud Book, the number of runners permitted in stakes is <del>as follows</del>:

a. Open stakes: maximum 12, minimum 10.b. Other stakes: maximum 12, minimum 8.

(Insertion in bold. Deletions struck through.) (Effective 1 July 2021)

# Field Trial J Regulations Clarification

Clarification has recently been sought in relation to preference in an Open Stake for HPRs. The relevant regulation is as follows:

Regulation J7.i.(4)

TO:

- i. Preference in the draw for Open Stakes
  - (4) Breeds which Hunt Point and Retrieve
    - A First Second or Third in an Open Stake

A First or Second in an All-Aged Stake or First in a Novice-Stake

A First and Second in All-Aged Stakes

A First in an All-Aged Stake and a First in a Novice Stake Two Firsts in Novice Stakes (Deletions struck through. Insertion in bold) (Effective 2 February 2021) (Subject to three year trial period and review in February 2024)

It should be noted that a dog that had previously gained an award which gave it preference in a draw for an open stake, i.e. A First or Second in an All-Aged Stake or First in a Novice Stake, prior to 2 February 2021 retains the qualification for preference in an open draw without the requirement for additional awards.

## Kennel Club Judges' Training Programme Seminar

Although the deadline for attending the seminar and passing the examination has already been extended due to Covid-19, in the interests of clarity the revised deadline has been included within the relevant J regulation.

As such, the Board approved the following amendment to the J Regulations:

Regulation J6.c.(6):

TO:

(6) Before a judge can be added to a Panel he must have attended a Kennel Club Judges' Training Programme seminar on Kennel Club J Regulations for the appropriate sub-group and have passed the examination. With effect from <del>1 January-2022</del> **2 February 2023** to remain on a judging Panel, all judges must have attended a Kennel Club Judges' Training Programme seminar on Kennel Club J Regulations for the appropriate sub-group and must have passed the examination, unless the judge has "Grandfather rights" (see note).

(Deletion struck through. Insertion in bold.) (Effective 1 July 2021)

(Note: Judges deemed to have "Grandfather rights" and who are therefore exempt from Regulation J6.c.(6) are: judges who were appointed to the 'A' Panel prior to 1 January 2010, and/ or were involved in the pilot scheme for the judges training programme and/or those who are, or have been a Kennel Club Approved Presenter).

# Message from The Kennel Club regarding awards gained at licensed events


The Kennel Club would like to apologise to competitors at forthcoming licensed events that the operational issues currently being experienced will impact upon the issuing of award certificates by our office.

# **Obituary to Michael Marjoram**



Michael Marjoram joined Skinner's in 1980 and was responsible for delivering dog food to Skinner's customers throughout the UK. Whatever the weather, customers knew they could depend on Michael and on many occasions the little blue lorry would be a welcome sight, having ploughed it's way through snowdrifts or floods to deliver their dog food. Michael was highly regarded by all Skinner's customers and became a firm friend to many of them. In 1990 Michael moved to the position of General Manager and later became a Director, with responsibility for the production and distribution of all Skinner's foods. It was not long before Michael was travelling to Europe and the USA to review equipment and this combined with the various trade fairs in Germany, Holland, France, and Italy meant that he became a much travelled man.

As the Skinner's show circuit increased from 10 events a year to over 40 Michael attended them all, from Crufts to The Game Fair, gundog championships and Olympia. He was always the first man on site during a championship and would be there in the dark, wind, rain, hail, snow and frost to get the kettle on so all competitors and spectators had a hot cup of tea. He would also be the last to leave once everyone had had a cup of the famous Skinner's Tomato Soup.

Michael's knowledge of the Skinner's business was unrivalled and he remained as always, a great asset to the company. He loved football and fishing, he was a season ticket holder at Norwich City and spent many days a year fishing. He leaves behind a son and daughter, seven grandchildren and three great grandchildren.

The Kennel Club will forever be grateful for Michael's commitment to the world of gundogs and he will be greatly missed.
