- Where an individual is nominated to judge with Challenge Certificates for the first time a completed questionnaire must be included with this nomination, **or an indication given that the judge has been approved by the Kennel Club for inclusion on a Breed Club A2 Judges List.**
- A questionnaire is not required for FCI Judges resident overseas provided they have previously awarded CACIBs to the relevant breed(s) in countries other than their country of residence for a minimum period of 5 years prior to their first UK appointment for the breed(s) and are listed as designated 'International Judges' in the Judges Directory published by the FCI. All other nominations for overseas' judges to award Challenge Certificates for the first time must be accompanied by a questionnaire.
- With effect for all nominations received at the Kennel Club on or after 1st January 2018, the minimum period of time between Challenge Certificate appointments to the same sex of the same breed, will increase from 12 to 18 months.
- This judges nomination form must be forwarded to the Kennel Club at least 12 months prior to the date of the Show Regulation F(1)24k refers.
- Please provide a stamped addressed postcard if you require an acknowledgement of receipt at the Kennel Club.
